



CHAMPION MEMBER AGREEMENT

A Champion Member is defined as follows:

- USA Olympic or Paralympic Medalist
- USA Senior World Target Outdoor Individual Gold Medalist (Recurve or Compound)
- USA Senior World Target Indoor Individual Gold Medalist (Recurve or Compound)
- World Archery Gold Plaque (USA) Recipient

GUIDELINES

- Champion Members have access to the Easton Archery Centers indoor/outdoor range for open shoot only during normal business hours.
- Champion Members will have access to the workshop during normal business hours.
- Access is dependent upon availability.
- No afterhours access allowed.
- Blackout dates/times may apply.
- Family members or guests visiting with Champion Member during normal business hours would be required to pay current shooting fee. Signed waiver required.
- Spouse/Partner/Family Shooting Pass option - \$180.00 annually per person. Must be accompanied by Champion Member while using the center. Shooting pass is for open shoot only during normal business hours.

TERMS & CONDITIONS

- Easton Archery Centers reserves the right to vary, add or eliminate any of the services and facilities provided.
- Easton Archery Centers reserves the right to partially or fully close and be unavailable for use for reasons including, but not limited to, renovation, repair, tournaments, special events, or holidays.
- Easton Archery Centers reserves the right to close or modify facility hours with or without notice. Easton Archery Centers will make every effort to minimize disruption during these periods. Hours of operation will be displayed in the Facility and may be modified from time to time.
- Signed waivers (general, workshop) must be signed in conjunction with this agreement.
- Champion Member agrees to comply with all center rules, archery range rules and policies.
- The Champion Member is ultimately responsible for the conduct and actions of their spouse/partner or family members while using the center.
- EASTON ARCHERY CENTER OF EXCELLENCE usage is dependent upon availability and approval from USA Archery. Center access must be reserved and approved in advance.
- The Easton Archery Centers defines "Family" as a spouse/partner and immediate family members up to 18 years of age living at the same address.
